539 Jacquelyn said Tito missed his court date, resulting in a warrant out for his arrest. Tito blamed
540 Jacquelyn for giving Malachy to her mother, taking his vehicle and his current warrants for arrest. Tito
541 located Jacquelyn and forced her (by bribing her with drugs), to go with him. Once he had her back
542 under his control, he began to abuse her again and chained her up to his bedroom door frame.
543
544 ****NOTE: During this time, Tito was using Facebook to try and make contact with Brenda Lee, and
545 asked his friends to help him find Malachy. *****

547 On February 24, 2016 Jacquelyn said things got worse when the bounty hunters showed up at Mary
548 Lou's home, located at 2214 Arno St. SE, looking for Tito on outstanding warrants. Tito was able to flee
549 before the bounty hunters could capture him. When the bounty hunters kicked in the door, Mary Lou
550 was struck in the face with the door. She screamed and distracted the bounty hunter while Tito
551 escaped. Tito backtracked and returned to 2214 Arno St SE a few hours later. He told Jacquelyn they
552 would be staying with a friend, Michelle Cruz Aka "Mousie".
553
554 From the evening of February 24, 2016 through February 26, 2016 Tito forced Jacquelyn to stay inside
555 a room at Michelle's residence located in the Valley Gardens neighborhood. Tito received a phone call
556 from Mary Lou in reference to needing a ride from the hospital (due to the injury from bounty hunters
557 kicking in the door). Tito asked Michelle Cruz to give them a ride to pick up his mother from the hospital.
558 On the way there, Jacquelyn said a police officer pulled them over in the area of Isleta Blvd and Rio
559 Bravo SW. When the vehicle came to a stop, Tito fled from the vehicle. When the police asked who
560 fled, Michelle and Jacquelyn denied knowing Tito. When the officers separated them, Jacquelyn felt
561 safe to tell the officers Tito's name and that he was preventing her from leaving (*refer to BSCO's report*
562 *16-623197*). Officers arrested Michelle Cruz for harboring a felon. Jacquelyn said she asked for a ride
563 but the officers were busy still looking for Tito and denied her a ride. She began to walk back to her
564 friends.

566 ****NOTE: Bernalillo County Sheriff's Department police report 16-623197 documented this incident as
567 follows and no mention of Jacquelyn being held against her will was noted:
568 On February 27, 2016 at approximately 0031 hours, Bernalillo County Sheriff Deputy Valente Marquez
569 #4487, conducted a traffic stop in the area of 3250 Isleta Blvd SW on a illegible license plate.
570 As the vehicle came to a stop, the front passenger exited the vehicle and fled southbound on foot.
571 Officer Valente Marquez #4487, observed a male running from the vehicle.*
572
573 *Officer V. Marquez identified both remaining occupants of the vehicle as Jacquelyn Barela and Michelle
574 Merritt (Aka Michelle Cruz). Jacquelyn identified the fleeing individual as her "baby daddy" name Tito*

575 Fajardo. She informed the officers that Michelle was aware that Tito had outstanding warrants and
576 allowed him to "hide out" at her residence after bounty hunters came to his mother's residence in
577 Albuquerque.

578

579 According to the police report, Michelle Merritt denied knowing Jacquelyn Barela and Tito Fajardo. After
580 additional questioning by BSCO, Michelle said she was aware Tito was "wanted" because he told her
581 he "was facing a lot of time". ***

582

583 Early the next morning, February 27, 2016 while she was still walking around, she stopped at the
584 Mushroom Store, located at 2405 Isleta Blvd. SW. As she was standing outside showing a friend a bag
585 of clothing an unknown vehicle drove up. Tito opened the door and told her to "get inside". Jacquelyn
586 tried to make a scene but Tito threw her inside the vehicle and told him she is "a dead bitch" because
587 she "ratted on him". Tito told Jacquelyn that the police had arrested his "home girl" (Michelle Cruz) and
588 the police were looking for him at his "home girl's pad and [his] mom's", and Jacquelyn was "walking
589 free". Tito called her a rat and took her back to his mom's house at 2214 Arno St. SE. Tito used chains
590 wrapped around her ankles, secured by locks, hooked through an attachment on his bedroom door
591 frame to prevent her from leaving. When he would leave, his mother, Mary Lou would ensure she could
592 not get free from the residence. Jacquelyn said Mary Lou would help Tito hold her down and then hit
593 and kick her all over her body, while calling her a "rat". Jacquelyn said Tito told her he was planning on
594 killing her for being a rat.

595

596 Jacquelyn said on Sunday night, February 28, 2016 while being held against her will, Tito had penis to
597 vagina sexual intercourse with her against her consent. She said she did not resist him because he
598 would punch her or hurt her if she tried to tell him no or tells him she does not want to have sex with
599 him.

600

601 Jacquelyn continued to tell me that on Monday, February 29, 2016 during the day, Mary Lou and Tito
602 held her down and shaved her head to symbolize her as a rat. Tito told her "As soon as I get the okay
603 from God, you're dead."

604 Jacquelyn said a neighbor, "Mike" saw her and did nothing about it.

605

606 ***NOTE: Michael Hess who lives at 2218 Arno St SE, was contacted by Detective G. Stone had stated
607 that he recently had seen Jacquelyn chained up with her head shaved inside 2214 Arno ST SE. It is
608 believed this is the person Jacquelyn referred to as "Mike" (refer to Detective G. Stone's lapel video). **

609

610 On Tuesday, March 1, 2016 Jacquelyn said she was "pissed" that Tito had shaved her head. Tito
